Abstract: The Slender-billed Curlew (*Numenius tenuirostris*) is for the last time reliably recorded at 23 February 1995 at Merja Zerga, Morocco. This paper re-evaluates the recent addition by Hudeček (2016) of the species to the Czech Republic list.

Introduction

The recent addition of Slender-billed Curlew *Numenius tenuirostris* to the Czech Republic (Hudeček 2016), had prompted me to respond. Hudeček summarises first in his article the history of Slender-billed Curlew in general, followed by the occurrence in the Czech Republic and in central Europe to conclude with the occurrence in Bohemia. In the latter part, he added Slender-billed Curlew back to the Czech Republic list after rejection of the species from the list by Vavřík (2015). Hudeček (2016) makes reference herein to records from Jiří Janda.

The Slender-billed Curlew in the Czech Republic

Clear from recent reviews by Kirwan *et al.* (2015) and Wassink (2016) is that very few records remain acceptable after review. Therefore, any Slender-billed Curlew sighting with a decent description or photo is greatly welcomed. As identification of Slender-billed Curlew is not straightforward and difficulties are involved, the main characters need to be accessed (Corso *et al.* 2014).

The addition to the Czech Republic list does in my opinion not meet the current standards for record documenting. It is inadequately documented, with no written description, a mounted specimen, unknown year of collecting and even the collecting locality is unknown. So therefore, by no means Eurasian Curlew *Numenius arquata* or Whimbrel *Numenius phaeopus* can be excluded as potential pitfall (Corso *et al.* 2014).

Conclusion

In line with Vavřík (2015) there are no decent documented records for the Czech Republic.
