# Akbar Zada, Mohammad Yar and Tongxing Li <br> Existence and stability analysis of nonlinear sequential coupled system of Caputo fractional differential equations with integral boundary conditions

#### Abstract

In this paper we study existence and uniqueness of solutions for a coupled system consisting of fractional differential equations of Caputo type, subject to Riemann-Liouville fractional integral boundary conditions. The uniqueness of solutions is established by Banach contraction principle, while the existence of solutions is derived by Leray-Schauder's alternative. We also study the Hyers-Ulam stability of mentioned system. At the end, examples are also presented which illustrate our results.


## 1. Introduction

The subject of fractional calculus (calculus of integrals and derivatives of any arbitrary real or complex order) has gained considerable popularity and importance during the past three decades or so, mainly due to its demonstrated applications in numerous fields of science and engineering. Historically, the first appearance of the concept of a fractional derivative was found in a letter by the famous mathematician Gottfried Leibniz $(1646-1716)$ in 1695 to a French mathematician Guillaume de L'Hospital (1661-1704). Leibniz introduced the following symbol $\frac{d^{n}}{d t^{n}} f(t)$ which denotes the $n^{t h}$ order derivative of a function $f$ with the hypothesis that $n \in \mathbb{N}$ and reported this to L'Hospital. So L'Hospital posed a question; what will be the derivative if $n=\frac{1}{2}$ ? Leibniz replied to him on September $13^{t h}, 1695$ and wrote: "This is an apparent paradox from which, one day useful consequences will be drawn" 8].

[^0]In the last few decades, fractional differential equations have gained much attention due to extensive applications of these equations in the mathematical modeling of physical, engineering, biological phenomena and viscoelasticity etc, [13]. Several interesting and important results concerning the existence and uniqueness of solutions, stability properties of solutions, analytic and numerical methods of solutions for fractional differential equations can be found in the recent literature. Fractional-order operators are nonlocal in nature and take care of the hereditary properties of many phenomena and processes. Fractional calculus has also emerged as a powerful modeling tool for many real world problems, see [2, 6, 9, 17.

The study of coupled systems involving fractional differential equations is also important because these systems occur in various problems of applied nature. Coupled systems of fractional differential equations have also been investigated by many authors. Such systems appear naturally in many real world situations, for example, see [4]. Some recent results on the topic can be found in [5, 7, 19, 18, 23, 24].

Moreover, the theory of fractional order differential equations, involving different kinds of boundary conditions has been a field of interest in pure and applied sciences. Nonlocal conditions are used to describe certain features of applied mathematics and physics such as blood flow problems, cellular systems [1], chemical engineering, thermo-elasticity, underground water flow, population dynamics [10], and so on. For boundary value problems with integral boundary conditions and comments on their importance, we refer the reader to [3, 21, 22, 26, 27, 29, 31, 30, (36, 37.

In 1940, Ulam asked: "Under what situation we can have a function(additive) near an approximate function(additive)"? see [12]. After twelve months, Hyers gave answer(partial) to Ulam [25] in the form of complete normed spaces. Since then, this concept of stability is known as Ulam-Hyers stability. Rassias [16] extended the mentioned concept of stability to general variables. For different approaches [14, 15, 20, 28, 34, 32, 33, 35].

In this paper, we study the nonlinear sequential coupled system of Caputo fractional differential equations with Riemann-Liouville fractional integral boundary conditions of the following form

where ${ }^{c} D^{q},{ }^{c} D^{p}$ denote the Caputo fractional derivatives of order $p, q, I^{\rho_{i}}, I^{\gamma_{j}}$ are the Riemann-Liouville fractional integral of order $\rho_{i}, \gamma_{j}>0, \eta_{i}, \theta_{j} \in(0, T)$, $k \in \mathbf{R}^{+}, f, g:[0, T] \times \mathbf{R}^{2} \rightarrow \mathbf{R}$ and $\alpha_{i}, \beta_{j} \in \mathbf{R}, i=1,2, \ldots, n, j=1,2, \ldots, m$ are real constants such that

Here, we emphasize that the integral boundary conditions (1) can be understood in the sense that the value of the unknown function at an arbitrary position $\eta_{i}, \theta_{j} \in(0, T)$ is proportional to the Riemann-Liouville fractional integral of the unknown functions

where $\rho_{i}, \gamma_{j}>0$. Further, for $\eta_{i}=\theta_{j}=1$, the integral boundary conditions reduce to the usual form of a nonlocal integral conditions

We show the existence of solutions for problem (1) by applying Leray-Schauder alternative criterion while uniqueness of solutions for (1) relies on Banach contraction mapping principle. The rest of the paper is organized as follows: In Section 2 we recall some preliminary concepts which we will need in the sequel. Section 3 contains the main results for problem (11). In Section 4, we present the Hyers-Ulam stability of problem (1).

## 2. Preliminaries and background materials

In this section, we introduce some notations and definitions of fractional calculus and present preliminary results needed in our proofs.

Definition 2.1
The Riemann-Liouville fractional integral of order $q>0$ of a function $f:(0, \infty) \rightarrow$ $\mathbf{R}$ is defined by

Taking the Riemann-Liouville fractional integral of order $\rho_{i}>0$ for (5) and $\gamma_{j}>0$ for (6) and using the property of the Riemann-Liouville fractional integral, we get

Substituting the values of $A_{1}, A_{2}, B_{1}$ and $B_{2}$ in (5) and (6), we obtain the solutions (3) and (4).

## 3. Main results

Throughout this paper, for convenience, we use the following expression

where $v \in\left\{t, T, \eta_{i}, \theta_{j}\right\}, w=\{p, q\}$ and $h=\{f, g\}, i=1,2, \ldots, n, j=1,2, \ldots, m$. Let $\mathcal{C}=C([0, T], \mathbf{R})$ denotes the Banach space of all continuous functions from $[0, T]$ to $\mathbf{R}$. Let us introduce the space $X=\left\{x(t): x(t) \in C^{1}([0, T])\right\}$ endowed with the norm $\|x\|=\sup \{|x(t)|, t \in[0, T]\}$. Obviously, $(X,\|\cdot\|)$ is a Banach space. Also let $Y=\left\{y(t): y(t) \in C^{1}([0, T])\right\}$ be endowed with the norm $\|y\|=$ $\sup \{|y(t)|, t \in[0, T]\}$. Clearly, the product space $(X \times Y,\|(x, y)\|)$ is a Banach space with the norm $\|(x, y)\|=\|x\|+\|y\|$. In view of Lemma 2.5, we define the operator $\mathcal{T}: X \times Y \rightarrow X \times Y$ by

## 4. Hyers-Ulam stability of system (1)

This section is devoted to the investigation of Hyers-Ulam stability for our proposed system. Consider the following inequality:

Problem (1) is Hyers-Ulam stable if there exist $M_{i}>0, i=1,2,3,4$ such that for given $\varepsilon_{1}, \varepsilon_{2}>0$ and for each solution $(x, y) \in C\left([0, T] \times \mathbf{R}^{2}, \mathbf{R}\right)$ of inequality 13$)$, there exists a solution $\left(x^{*}, y^{*}\right) \in C\left([0, T] \times \mathbf{R}^{2}, \mathbf{R}\right)$ of problem (1) with

\left|y(t)-y^{*}(t)\right| \leq M_{3} \varepsilon_{1}+M_{4} \varepsilon_{2} \tag{15}
\end{equation*}
$$

where $M_{i}, i=1,2,3,4$ are given by (7)-10). Hence Remark 4.3 is verified, with the help of $(14)$ and $(15)$. Thus the nonlinear sequential coupled system of Caputo fractional differential equations is Hyers-Ulam stable and consequently, the system (1) is Hyers-Ulam stable.

## 5. Examples

Example 5.1
Consider the following system of coupled Caputo fractional differential equations with Riemann-Liouville fractional integral boundary conditions

\quad=\frac{1}{24} \cos x(t)+\frac{1}{(t+6)^{2}} \sin y(t)+1, \quad t \in[0,2] \\
x(0)=0, \quad x(2)=\frac{3}{2} I^{1 / 3} y(2 / 3)+\sqrt{2} I^{3 / 7} y(4 / 3) \\
y(0)=0, \quad y(2)=\sqrt{3} I^{1 / 4} x(1 / 2)+\frac{1}{2} I^{4 / 7} x(1)+2 I^{7 / 10} x(3 / 2)
\end{array}\right.
$$

Here $q=5 / 2, p=7 / 3, n=2, m=3, T=2, \alpha_{1}=3 / 2, \alpha_{2}=\sqrt{2}, \beta_{1}=\sqrt{3}$, $\beta_{2}=1 / 2, \beta_{3}=2, \rho_{1}=1 / 3, \rho_{2}=3 / 7, \gamma_{1}=1 / 4, \gamma_{2}=4 / 7, \gamma_{3}=7 / 10, \eta_{1}=2 / 3$, $\eta_{2}=4 / 3, \theta_{1}=1 / 2, \theta_{2}=1, \theta_{3}=3 / 2$ and

$$
\begin{aligned}
& \left.f(t, x, y)=\left(e^{t^{2}}|x|\right) /(t+7)^{2}\right)(1+|x|)+(\sin (2 \pi t)|y|) /\left(3 e^{t}+1\right)^{2}(1+|y|)+1 / 3 \\
& g(t, x, y)=(\cos x / 25)+(\sin y) /\left((t+6)^{2}\right)+1
\end{aligned}
$$

Since

$$
\left|f\left(t, x_{2}, y_{2}\right)-f\left(t, x_{1}, y_{1}\right)\right| \leq(1 / 49)\left|x_{2}-x_{1}\right|+(1 / 16)\left|y_{2}-y_{1}\right|
$$

and

$$
\left|g\left(t, x_{2}, y_{2}\right)-g\left(t, x_{1}, y_{1}\right)\right| \leq(1 / 25)\left|x_{2}-x_{1}\right|+(1 / 36)\left|y_{2}-y_{1}\right|
$$

and we can find

\Omega=T^{2}-\sum_{i=1}^{n} \frac{\alpha_{i} \eta_{i}^{\rho_{i}+1}}{\Gamma\left(\rho_{i}+2\right)} \sum_{j=1}^{m} \frac{\beta_{j} \theta_{j}^{\gamma_{j}+1}}{\Gamma\left(\gamma_{j}+2\right)} \simeq-8.442 \neq 0
$$

With the given values, it is found that $m_{1}=1 / 49, m_{2}=1 / 16, n_{1}=1 / 25$, $n_{2}=1 / 36, M_{1} \simeq 3.358, M_{2} \simeq 1.795, M_{3} \simeq 3.303, M_{4} \simeq 2.331$, and

$$
\left(M_{1}+M_{3}\right)\left(m_{1}+m_{2}\right)+\left(M_{2}+M_{4}\right)\left(\left(n_{1}+n_{2}\right) \simeq 0.825<1\right.
$$

Thus all the conditions of Theorem 3.1 are satisfied. Therefore, by the conclusion of Theorem 3.1. the problem (16) has a unique solution on [0,2]. Further, it is also straightforward to prove the problem (16) is Hyers-Ulam stable.

## Example 5.2

Consider the following coupled fractional integral boundary conditions

=\frac{\sin (2 \pi x(t))}{172 \pi}+\frac{1}{10 \sqrt{t+4}}+\frac{|y(t)|}{60(1+|y(t)|)}, \quad t \in[0,4] \\
x(0)=0, \quad x(4)=\frac{3}{2} I^{7 / 10} y(1 / 2)+\sqrt{5} I^{3 / 7} y(2 / 3) \\
y(0)=0, \quad y(4)=\sqrt{7} I^{3 / 4} x(5 / 4)+\frac{11}{7} I^{9 / 8} x(2 / 3)
\end{array}\right.
$$

Here $q=9 / 4, p=12 / 5, n=2, m=2, T=4, \alpha_{1}=3 / 2, \alpha_{2}=27, \beta_{1}=\sqrt{7}$, $\beta_{2}=11 / 7, \rho_{1}=7 / 10, \rho_{2}=3 / 7, \gamma_{1}=3 / 4, \gamma_{2}=9 / 8, \eta_{1}=1 / 2, \eta_{2}=2 / 3, \theta_{1}=5 / 4$, $\theta_{2}=2 / 3$ and

\begin{aligned}
& f(t, x, y)=|x(t)| /(t+3)^{4}(1+|x(t)|)+1 / 63\left(1+y^{2}(t)\right)+1 / 18 \\
& g(t, x, y)=\sin (2 \pi x(t)) / 172 \pi+1 / 10 \sqrt{t+4}+|y(t)| / 60(1+|y(t)|)
\end{aligned}
$$

Since

$$
\left|f\left(t, x_{2}, y_{2}\right)-f\left(t, x_{1}, y_{1}\right)\right| \leq(1 / 81)\left|x_{2}-x_{1}\right|+(1 / 63)\left|y_{2}-y_{1}\right|
$$

and

$$
\left|g\left(t, x_{2}, y_{2}\right)-g\left(t, x_{1}, y_{1}\right)\right| \leq(1 / 86)\left|x_{2}-x_{1}\right|+(1 / 60)\left|y_{2}-y_{1}\right|
$$

and we can find

$$
\Omega=T^{2}-\sum_{i=1}^{n} \frac{\alpha_{i} \eta_{i}^{\rho_{i}+1}}{\Gamma\left(\rho_{i}+2\right)} \sum_{j=1}^{m} \frac{\beta_{j} \theta_{j}^{\gamma_{j}+1}}{\Gamma\left(\gamma_{j}+2\right)} \simeq-28.38879 \neq 0
$$

With the given values, it is found that $m_{1}=1 / 81, m_{2}=1 / 63, n_{1}=1 / 86$, $n_{2}=1 / 60, M_{1} \simeq 14.38186, M_{2} \simeq 5.15674, M_{3} \simeq 7.46746, M_{4} \simeq 3.61879$, and

$$
\left(M_{1}+M_{3}\right)\left(m_{1}+m_{2}\right)+\left(M_{2}+M_{4}\right)\left(\left(n_{1}+n_{2}\right) \simeq 0.86485<1\right.
$$

Thus all the conditions of Theorem 3.1 are satisfied. Therefore, by the conclusion of Theorem 3.1 the problem (17) has a unique solution on [0,4]. Further, it is also straightforward to prove the problem (17) is Hyers-Ulam stable.

## 6. Conclusion

We discussed the existence and stability of nonlinear sequential coupled system of Caputo fractional differential equations with Riemann-Liouville fractional integral boundary conditions. The existence and uniqueness of solutions is relies on Banach contraction principle, while the existence of solutions is established by applying Leray-Schauder's alternative. Finally examples are presented to illustrate the main results.
