Instructions for authors

Scope

European Pharmaceutical Journal publishes only original articles not previously published and articles that are not being considered or have not been submitted for publication elsewhere. If parts of the results have been published as conference abstract or elsewhere, it should be stated in references. The ethical standards of the Helsinki-Tokio Declaration should be kept. This should be mentioned in the Methods of manuscript.

Reviews are published only on request.

Authors, whose submitted research work was performed with the support of a company, should indicate this in Conflict of Interest.

Submission of Manuscripts

All manuscripts must be submitted electronically via http://www.editorialmanager.com/eurpharmj. Submit via online submission at editorial manager. You will be asked to create a user account and follow the step by step instructions. Once you have created a user account, it will be available to you for all future submissions and will remember all the correspondent information that you previously entered. Before proceeding to the online submission site, please prepare your manuscript according to the instructions listed above (preparing manuscript). You can leave your submission any time and it will be saved in the folder as incomplete submission.

The instructions below are meant to help guide you through the submission process.

- Tables in a separate file. Please note that, for publication purposes, all tables must be provided in an editable text format. Excel or PDF files will not be accepted.
- Figures in a separate file. Please note that, for publication purposes, all figures must be provided in TIFF (300 DPI) in a separate file.
- Open Access License License to publish/
- Conflict of interest (if applicable)
- Graphical abstract (optional)
- Supplementary information (optional)

Preparing the manuscript

The length of the manuscript should not exceed more than 10 pages (Times New Roman 10, spacing 1), in case of a review 16 pages (Times New Roman 11, spacing 1). **The subheadings**

should be written in Times new roman 10, capitals, alighted to the centre, after every subheading a break of 10 points should be kept, after every section 2 breaks of 10 points should be kept.

As language of publication is English, please, ensure that your manuscript has been checked by an English language expert. Manuscripts written by authors who are not English native speakers should be checked by an English native speaker before submission.

Original research articles should be structured in the following sections:

TITLE PAGE

The full English title of the manuscript should be short, concise and descriptive. Secondary, Slovak/Czech title is optional. Full names of authors with e-mail contact, full address of the institution, department or clinic where the work has been performed but without concise academic and professional degrees should be used. Ensure about the first and corresponding authors. Include the information about funding (funder, award number, grant recipient).

COVER LETTER

The cover letter should include the information about the importance of the paper in the field. It has to state that that the manuscript has not been published or has not been submitted for a publication, or is not under review elsewhere. Further the cover letter should include at least two competent reviewers, their names, affiliations, current position, and contact. This proposal is not binding for the Editorial Board. Don't forget oppose reviewers, if applicable.

ABSTRACT AND KEYWORDS

The abstract of the manuscript should contain **no more than 300 words**. It should convey the following: Aim; Material/Methods; Results; Conclusions; Keywords. The abstract should summarize relevant information. It should state the purpose of the investigation, basic procedures, main findings together with their statistical significance (if necessary), and principal conclusions. Up to 5 Key words are also to be provided for the purpose of indexing - on a new line underneath the abstract. Secondary, Slovak/Czech abstract, keywords are optional.

INTRODUCTION, METHODS, RESULTS AND DISCUSSION

These should be separate sections.

The Introduction should make clear the hypothesis being examined/rationale for the study in the context of the literature.

Subsections should be used in the methods with headings such as Animals; Chemicals; Experimental Design; Treatments; Tissue Preparation etc. Sufficient detail should be presented in the methods to allow independent replication of the study (previously published work can be referenced for full details but salient information should still be presented such that the article can stand alone). The source and supply of all materials used must be provided. This includes all chemicals, reagents, culture media etc. The species, strain, supply, age, sex of animals must be clearly stated together with their maintenance (including temperature, humidity, light cycle,

caging and supplier of food). For repeat dose studies animals' reaction to treatment (clinical signs, bodyweight gain during the course of treatment) should be measured and reported in the results. Appropriate welfare guidelines should be stated. Apply by analogy to clinical or biomedical experiments.

The results should describe the key findings referring to all tables and figures (statistical P values should not be repeated if given in tables or figures). The discussion should place the findings in context with the literature and highlight the advancements made by the study (eg to mechanistic understanding).

TABLES

Tables should be submitted separately in word file. Each table should be cited in the text and supplied with a brief title on the top of the table (Times New Roman 10, bold, spacing 1, example: **Table 1**. **Changes in blood pressure**). In every table all the abbreviations and non-standard units should be explained.

FIGURES

Figures should be submitted separately. Black and white color or grey shading is preferred. They should be numbered in Arabic numerals in order of appearance in the text, where they are referred to as Fig. 1, Fig. 2, etc. Figures that include more than one image should be organized economically and labeled as a, b, c, etc. (small letters). Under every figure a brief title has to be cited (Times New Roman 10, bold, spacing 1, example: Figure 1. Changes in blood pressure). In every figure all the abbreviations and non-standard units should be explained.

Photographs must be in TIFF format, preferred resolution 300 dpi. Graphs must be in TIF, format, preferred resolution 300 dpi

ACKNOWLEDGMENTS

If applicable, max. 800 characters incl. spaces

The acknowledgments of the contributions of colleagues can be stated in this section as well as acknowledgments for financial support. If the manuscript was written for the occasion of personal or institutional anniversary it should be mentioned here.

UNITS OF MEASUREMENT

Units of measurement should be in accordance with International System of Units (SI).

ABBREVIATIONS

Avoid abbreviations in the title and abstract except well-known or official nomenclature-based ones. The full term for which an abbreviation stands should precede its first occurrence in the text, further in the text abbreviation should be used only.

REFERENCES

Each mentioning of statements or findings by other authors should be supported by reference. Cited references in the text are to be cited using the surname(s) of the author(s) followed by the year of publication of the work referred to, e.g. (Huddle, 2010), (Huddle & Smith, 2010). In case of more than two authors, use name of first author followed by "et al.", e.g. (Smith et al., 2010). If several works are cited, they should be organized alphabetically, starting with A. If more than one publication of same author(s) use the surname followed by the oldest work first, e.g.: (Huddle et al., 1993, 1996). Avoid using abstracts and personal communications as references (the latter can be cited in the text). The list of the cited literature should be added at the end of the contribution. Literature should be cited according to the enclosed instructions that are in accordance with those used by U. S. National Library of Medicine in Index Medicus.

The titles of journals should be abbreviated according to the style used in Index Medicus (complete list on the URL address: http://www.nlm.nih.gov).

Note: For six or fewer authors, list all author names. For seven or more authors, list the first three author names, then "et al."
