## AUTHORSHIP STATEMENT:

Following International Committee of Medical Journal Editors (ICMJE) guidelines (see Guide for Authors, section 1.3.2)

The Authorship statement should be signed by each author. In cases where obtaining a signature from each author would unduly delay publication, the corresponding author's signature is sufficient provided that the corresponding author understands that he or she signs on behalf of the other authors who have not signed the form. If it is not possible to obtain the signature of a particular author (owing to death, loss of contact, or other reasons), the corresponding author should explain the circumstances in each instance.

The Editors of *Asian Biomedicine* expect each author to have: (1) made an important contribution to the conception and design, acquisition of data, or analysis and interpretation of data in the study; (2) drafted or revised the manuscript critically for intellectual content; and (3) approved the final version of the submitted manuscript. Those who meet all three criteria should be included as authors. Those who do not meet all three criteria should not be included as authors. The Editors also expect each author to meet **criterion 4** (1) take responsibility for at least one component of the work; (2) have access to the raw data and figure files for their component of the work; (3) be able to identify who is responsible for each other component; and (4) be confident in their coauthors' ability and integrity. One author, usually the corresponding author, must be thoroughly familiar with the original data for the entire study and be responsible for the integrity of the entire work. If the article, or part of the article, is found to be faulty or fraudulent, all coauthors may share responsibility.
