

# DRAFTING INSTRUCTIONS

## Frequency:

The Journal of Legal Studies appears every semester, in the months of **June and December**.

Submission of article for publication will be made as follows:

For **volume I**, final papers will be sent **no later than the end of Aprilie**.

For **volume II**, final papers will be sent **no later than the end of October**.

The texts of the articles will be drafted in English.

The title of the article, the abstract and the keywords will be drafted both in Romanian and in English.

The abstract of the text must have between 100-150 words.

Keywords: 5 keywords.

The final dimension of the text must have **minimum 5000 words**.

The texts of the articles must have the following parts: abstract, keywords, introduction, and the corpus of the paper, conclusions and bibliography.

The journal does not have article processing charges (APCs) nor article submission charges

In the following we will explain:

### **TITLE OF THE PAPER**

(dimension 14, Palatino Linotype, bold, centered)

Surname and complete NAME of the author(s) (bold)

Workplace (full name)

Address of the workplace

e-mail of the person in contact

(all with the dimension 12, Palatino Linotype)

**Abstract:** (100-150 words) (dimension 12, Palatino L, italic).

**Keywords:** between 3 and 5 words (dimension 12, Palatino L, bold).

**The text of the article** (minimum 5000 words, dimension 12, Palatino L, Line spacing 1,5).

Tables, diagrams and figures or other drawings will be inserted in the text in the right place, will be numbered and will have a good resolution.

Footnotes will have the following format:<sup>1</sup> or<sup>2</sup>, or<sup>3</sup>.

Within the text their will not be used abbreviations of the names of institutions, organisations, etc.

Quotations will be given between quotes: ".....".

**Bibliography:** will be placed at the end of the text, in an alphabetical order:

1. Name, Surname of the author, *Title of the book*, Publishibg House, City, Year.
2. Name, Surname of the author, "Title of the Article", *Name of the Journal*, no./Year, pp.
3. Name, Surname of the author, "Title of the Article", Surname and Name of the editors (eds.), *Title of the book*, Publishibg House, City, Year.

In case of using bibliographical references from the Internet, the author will indicate the web page and the date of access.
