

Author Guidelines

Contributions

Studies in Second Language Learning and Teaching welcomes previously unpublished articles in the field of learning and teaching second and foreign languages. The contributions can take the form of original research reports, replication studies, review articles, state of the art papers, reply articles and book reviews. The papers should be in the range of 6000-8000 words and book reviews about 1000 words in length. Contributions should be submitted electronically through the website of Adam Mickiewicz University Pressto platform:

<http://pressto.amu.edu.pl/index.php/ssllt/information/authors>. This will require registering as an author as well as fulfilling a number of conditions listed on the website including the provision of ORCID IDs of all the authors. Format

Manuscripts should be submitted as Microsoft Word or RTF files. In cases where extensive graphics or phonetic symbols are used an accompanying PDF file is recommended. Each paper must contain an abstract of 150-200 words, up to 5 keywords, and a note about the author of about 100 words. A separate title page should be provided which, apart from the title of the submission, should also include full names of all the authors, their affiliations, e-mail and postal addresses. The title, but no information about contributors, should also be provided at the beginning of the text, preceding the abstract. The manuscripts must conform to the specifications of Publication Manual of the American Psychological Association (sixth edition). Basic Information about the style can be found at:

American English spelling should be used in all manuscripts.

Review

Submissions are subjected to a double-blind review process conducted by at least two referees who may be members of the Editorial Board and other experts in the field. Authors are notified of acceptance or rejection of their papers within three months of the submission date.

Complimentary copies

Authors of papers and reviews receive one copy of the issue in which their work is published.

Prevention of ghostwriting and guest authorship

Ghostwriting and guest authorship are violations of scientific honesty and publication ethics and all documented cases will be made public including the notification of appropriate institutions such as authors' employers, scientific societies, scientific editors' associations, etc.

Submission Preparation Checklist

As part of the submission process, authors are required to check off their submission's compliance with all of the following items, and submissions may be returned to authors that do not adhere to these guidelines.

1. APA 6 has been used, with the exception that sections and subsections should be numbered consecutively.
2. The submission has been anonymized (i.e., all the references to authors and co-authors have been removed) and it is accompanied by a file with a title page.
3. Suggestions of reviewers, including their affiliations and contact information, have been included in Comments to Editor.
4. All authors have obtained ORCID IDs and will provide them during the submission process.

Copyright Notice

1.1 The Author hereby warrants that he/she is the owner of all the copyright and other intellectual property rights in the Work and that, within the scope of the present Agreement, the paper does not infringe the legal rights of another person. The owner of the copyright work also warrants that he/she is the sole and original creator thereof and that is not bound by any legal constraints in regard to the use or sale of the work.

1.2. The Publisher warrants that is the owner of the PRESSto platform for open access journals, hereinafter referred to as the PRESSto Platform.
